The Madison County Sheriff's Department is accepting applications for Deputy Sheriff. This process will create a hiring list which will be valid until approx. September 30th, 2020

Requirements for appointment:

1. US Citizenship
2. Become a Madison County Resident within 6 months of appointment.
3. Be at least 21 years of age.
4. Earned a HS diploma or equivalent.
5. No convictions of serious misdemeanors or felonies.
6. No pattern of failure to follow state statutes.
7. Must have a valid driver license
8. Must meet all requirements for eligibility for the Indiana Law Enforcement Academy

You must have an active email account, or access to one, to be considered. You may also deliver your completed application to the Records Division at the Madison County Sheriff's Department. If you have an issue with this requirement contact the Records Division at 765-646-9290 (press 1 when prompted)

Application deadline is February 15th, 2019

Any application which is incomplete will not be accepted.

After preliminary background investigation, selected applicants will be invited to participate in the Physical Fitness Assessment. Date, location and times will be emailed to applicants.

The Madison County Sheriff's Department strongly recommends that you consult with your physician if you have any concerns about your physical capabilities or condition. All applicants must be able to perform physically exerting tasks to be eligible for this position.

Minimum standards for applicants to successfully pass the assessment are listed below. There are also videos on the Indiana Law Enforcement Academy website indicating the accepted protocols for the components to be successfully completed and scored. If you do not follow the protocols you will not receive credit for each component.
